WHEREAS, in accordance with Clause 48 (x) (e) of the MEMORANDUM OF ASSOCIATION (MoA) OF SYMBIOSIS INTERNATIONAL [DEEMED UNIVERSITY], 2019, the University framed [Prevention, Prohibition and Redressal of Sexual Harassment of Employees and Students in the University and its Constituent Institutes/ Departments/ Sections/ Offices/ Workplaces] Rules, 2019 vide Notification No. SIU/ U-28/821 dated 16th May, 2019.

AND WHEREAS, as per Chapter 3 of the said Rules the Internal Committee (IC) at Off Campus Centre of Symbiosis International (Deemed University) at Hyderabad constituted & notified vide Notification No. SIU/ U-28/833 dated 24th June, 2019.

AND WHEREAS, Presiding Officer under category (i) has taken over charge of Officiating Director, SLS, Hyderabad and one member under category (ii) is nominated as Presiding Officer; one non-teaching member under category (ii) was transferred to other campus; three student members under category (iii) have left the University after completion of their studies in April, 2021 Examination Season, hence these seats have fallen vacant.
