The Powers & Functions of the Board of Management and the procedure to be followed for conduct of meetings shall be as per Rules framed in this behalf.

The Board of Management notified vide Notification No. SIU/28/662 dated 22nd March, 2017 ceases to exist from the date of publication of this notification.
